TLA Panel on 2024 Primary Elections

July 18, 2024

Key Senate races:

Senate District 2 (Blount, Monroe, Polk and Part of Bradley County)

Open Seat: Senator Art Swann not running

Contested primary between Republicans Tom Hatcher, Rep. Bryan Richey & John Pullias. Democrat Patti Young in the general election.

- Tom Hatcher 2nd Q filing: brought in \$83,600, spent \$97,641 and has \$66,157 on hand.
- Hatcher's outstanding loan balance reported in the 2nd Q filing was \$7,500.
- Richey 2nd Q filing: brought in \$2,700 in the 2nd Quarter, spent \$1,087 and has \$1,613 on hand.
- Pullias 2nd Q filing: Pullias raised \$4,066, spent \$3,357, and has \$5,536 on hand.

Senate District 4 (Hawkins and Sullivan County)

Incumbent Senator Jon Lundberg v. primary opponent Bobby Harshbarger, son of Congresswoman Diana Harshbarger. Independent Dalia Price in the general election.

- Lundberg brought in \$252,995 in the 2nd Quarter, spent \$235,914 and has \$202,499 remaining on hand. Lundberg's outstanding loan balance included a self endorsement loan of \$20,000.
- Harshbarger brought in \$18,678 in the 2nd Quarter, spent \$149,643 and has \$59,035 remaining on hand. Harshbarger has an outstanding loan balance of \$190,000.

Senate District 6 (Part of Knox County)

Incumbent Senator Becky Massey is opposed in the Republican primary by Monica Irvine. Democrat Domonica Bryan in the general election.

- Massey brought in \$155,346 in the 2nd Q, spent \$67,882 and has \$684,633 on hand.
- Irvine brought in \$13,117 in the 2nd Q, spent \$31,213 and has \$32,392 on hand. Irvine has an outstanding loan balance of \$51,075.

Senate District 8 (Claiborne, Grainger, Hancock, Jefferson, Union, part of Sevier)

Incumbent Senator Frank Niceley v. primary opponent Jessie Seal. Democrat R.E. Ellison is in the general election.

- Niceley brought in \$85,256 in the 2nd Q, spent \$62,302 and has \$268,653 on hand.
- Seal brought in \$58,865 in the 2nd Q, spent \$34,992 and has \$26,292 remaining on hand.

Senate District 10 (Bledsoe, Marion and Sequatchie Counties and part of Hamilton County)

Incumbent Senator Todd Gardenhire v. Edward LeCompte. Winner to face Democrat Missy Crutchfield.

- Gardenhire raised \$36,851, spent \$102,865 and has \$102,081 on hand. Gardenhire has an outstanding loan balance of \$52,713.
- Edward LeCompte did not file a 2nd Q report but 1st Q 2024 reports indicate a balance of \$130.

Senate District 12 (Campbell, Clay, Fentress, Macon, Morgan, Overton, Pickett, Roane, Scott)

Incumbent Senator Ken Yager v. Teena Hedrick. Democrat Curtis Kelly and Independent Charles Hutson in the general election.

Yager v. Hedrick

- Brought in: \$131K v. \$7K
- Spent: \$73K v. \$11K
- On hand: \$621K v. \$4K

Senate District 18 (Sumner and Trousdale County)

Incumbent Speaker Pro Temp Ferrell Haile v. Chris Spencer in the Republican primary. Democrat Walter Chandler and two Independents in the general election.

- Haile's re-elect campaign account brought in \$215,984 during the 2nd Q, spent \$44,107 and has \$625,075 on hand.
- Haile PAC brought in \$25,400 during the 2nd Quarter, spent \$30,000 and has \$22,727 on hand.
- Spencer brought in \$24,932 in contributions and \$32,815 in loans in the 2nd Quarter, spent \$57,343 and has \$23,649 remaining on hand. Spencer has an outstanding loan balance of \$64,357 in the 2nd Q filing.

Senate District 24 (Benton, Carroll, Gibson, Henry, Houston, Obion, Stewart and Weakley Counties)

Incumbent Senator John Stevens v. Charles Cooper in the Republican primary. No Democrat running.

- John Stevens brought in \$29K, spent \$90K and has \$148K on hand.
- Charlie Cooper had less than \$1K in each measure.

Senate District 30 (Part of Shelby County)

Incumbent Senator Sara Kyle's Democratic primary opponent is Erika Stotts Pearson. Independent Mitchell Morrison in the general election.

- Kyle brought in \$9,750 during the 2nd Q, spent \$39,529 and has \$70,151 remaining on hand.
- Pearson has not submitted a report

Key House Races:

House District 4 (Unicoi and part of Carter County)

Open Seat: Rep. John Holsclaw not running

Two Republicans are running for the seat - Curt Alexander and Renea Jones and no Democrat is running.

- Curt Alexander brought in \$3,050 in contributions and \$25,000 received in loans during the 2nd Quarter, spent \$13,092 and has \$14,958 on hand. Alexander has an outstanding loan balance of \$25,000 in the 2nd Q filing.
- Renea Jones brought in \$60,313 during the 2nd Quarter, spent \$40,593 and has \$66,279 on hand. Jones has an outstanding loan balance of \$45K in the 2nd Q filing.

House District 12 (part of Sevier County)

Open seat: Rep. Dale Carr not running

3 republicans running in primary: Fred Atchley, Christian Brown, and Larry Linton

- Atchley brought in \$49,600 during the 2nd Quarter, spent \$33,704 and has \$68,079 on hand.
- Brown brought in \$544 during the 2nd Quarter, spent \$441 and has \$59.21 on hand.
- Linton brought in \$95 in contributions and \$23,500 in loans during the 2nd Q, spent \$13,507 and has \$16,147 on hand. Linton has an outstanding loan balance of \$34,753 in the 2nd Q filing.

The winner of the R primary will face Democrat Leslie Braddock in the General Election.

- Braddock brought in \$1,383 in the 2nd Quarter, spent \$1,074 and has \$1,658 on hand.

House District 13 (part of Rutherford County)

Incumbent Robert Stevens versus Republican primary opponent Jami Averwater.

- Stevens brought in \$67,800 in contributions and \$30K in loans during the 2nd Q, spent \$74,032 and has \$78,171 on hand. Stevens has an outstanding loan balance of \$60K reported in the 2nd Q.
- Averwater brought in \$67,210 during the 2nd Quarter, spent \$70,414 and has \$24,797 on hand.

The winner of the R primary will face Democrat opponent, Jonathan Yancey, in the general election.

- Yancey brought in \$11,995 in the 2nd Quarter, spent \$4,077 and has \$8,053 on hand.

House District 15 (Part of Knox county)

Democratic Primary race: Incumbent Representative Sam McKenzie and Dasha Lundy. No R running.

- Dasha Lundy less than \$1K on all fronts.
- Sam McKenzie brought in \$28K, spent \$21K, and has \$29K on hand.

House District 20 (part of Blount County)

- Open Seat: Rep. Bryan Richey running for Senate
- 3 Republicans in this primary - Nick Bright, Jason Emert and Tom Stinnett
 - Bright brought in \$5,300 in contributions and \$18,000 in loans received during the 2nd Quarter, spent \$6,566 and has \$7,795 remaining on hand. Bright has an outstanding loan balance of \$4,400 in the 2nd Q filing.
 - Emert brought in \$23,090 in contributions and \$50,000 in loans received during the 2nd Quarter, spent \$682 and has \$72,408 remaining on hand. Emert has an outstanding loan balance of \$50,000 in the 2nd Q filing.
 - Stinnett brought in \$10,640 during the 2nd Quarter, spent \$45,796 and has \$18,452 on hand. Stinnett has an outstanding loan balance of \$11,000 in the 2nd Q filing.
- The winner of the R primary will face Democrat Karen Gertz.
 - Gertz 2nd Quarter report only indicated cash on hand balance of \$182.11

House District 24 (Part of Bradley County)

Incumbent Representative Kevin Raper faces Troy Weathers in the Republican primary. No D running.

- Kevin Raper brought in \$45K, spent \$37K and has \$37K on hand.
- Troy Weathers brought in \$22,100 during the 2nd Q that includes a \$20 K self endorsement loan, spent \$680 and has \$21,420 on hand.

House District 27 (part of Hamilton County)

Incumbent Representative Patsy Hazlewood faces Michele Reneau.

- Hazlewood brought in \$146,757 during the 2nd Q, spent \$171,147 and has \$429,566 on hand.
- Reneau brought in \$56,923 during the 2nd Quarter, spent \$18,443 and has \$43,445 on hand.

Winner will face Democrat Kathy Lennon in the general election.

House District 28 (Part of Hamilton County)

Incumbent Representative Yusuf Hakeem faces Demetrus Coonrod in the Democratic primary.

Independent Thomas Brooks is in the general election.

- Hakeem brought in \$7,950 in contributions during the 2nd Quarter, spent \$57,059 and has \$23,006 on hand. Hakeem has an outstanding loan balance of \$8,462 reported in the 2nd Q.
- Coonrod did not receive any contributions during the 2nd Q, spent \$2K and has \$500 on hand.

House District 31 (Bledsoe, Rhea, Sequatchie and Van Buren Counties)

Incumbent Representative Ron Travis will face Richard Smith in the Republican Primary. Democrat Brittany Lynn Warfel and Independent Jay Jenkins are in the general election.

Ron Travis v. Richard Smith

- Brought in: \$6K v. \$6K
- Spent: \$17K v. \$6K
- On hand: \$93K v. \$59.00

House District 33 (part of Anderson County)

Incumbent Representative John Ragan faces Rick Scarbrough in the Republican primary. Winner will face Democrat Anne Backus.

- Ragan brought in \$33,486 in contributions during the 2nd Quarter, spent \$35,827 and has \$25,948 remaining on hand. Ragan has an outstanding loan balance of \$8,733 in the 2nd Q filing.
- Scarbrough brought in \$51,490 during the 2nd Q, spent \$34,872 and has \$33,478 on hand.

House District 34 (Part of Rutherford County)

Incumbent Representative Tim Rudd primary race versus Tucker Marcum in the Republican primary.

Winner will face Democratic Amelia Pant in the general election.

Tim Rudd v. Tucker Marcum

- Brought in: \$34K v. \$12K
- Spent: \$64K v. \$15K
- On hand: \$46K v. \$31K

House District 43 (Warren and White Counties)

Incumbent Representative Paul Sherrell faces Robert McCormick and Tim Lewis. No D running.

- Paul Sherrell brought in \$27K, spent \$14K, and has \$79K on hand.
- Robert McCormick brought in \$6K, spent \$15K and has \$14K on hand.
- Tim Lewis no report

House District 56 (West Nashville)

Incumbent Representative Bob Freeman faces Nick Forster-Benson in the Democratic primary.

- Freeman brought in \$90K, spent \$52K and has \$386K on hand.
- Forster-Benson has almost no money raised or on hand.

House District 60 (Part of Davidson County)

Open seat: Darren Jernigan not running

This race has 2 Republicans (Chad Bobo and Christopher Huff) and 3 Democrats (Tyler Brasher, Shaundelle Brooks, and John W. Parrish) running for this seat.

- Bobo brought in \$34,353 in the 2nd Q, spent \$18,572 and has \$16,130 on hand.
- Huff brought in \$3,809 in the 2nd Quarter, spent \$3,113 and has \$806 on hand.
- Brasher brought in \$41,431 during the 2nd Q, spent \$29,969 and has \$15,482 on hand.
- Brooks brought in \$52,865 in the 2nd Quarter, spent \$47,626 and has \$26,522 on hand.
- Parrish did not report any spending or funds collected during the 2nd Quarter.

House District 64 (part of Maury County)

Incumbent Representative Scott Cepicky faces Ray Jeter in the Republican primary. Democrats Eileen Longstreet and Alex Pierce face off in the Democrat primary.

- Cepicky brought in \$36,623 during the 2nd Quarter, spent \$25,652 and has \$40,886 on hand.
- Jeter brought in \$40,401 during the 2nd Q, spent \$12,127 and has \$30,173 on hand.
- Longstreet has \$1K on hand. Pierce has less than \$1K on hand.

House District 65 (part of Williamson County)

Open seat: Sam Whitson not running

3 Republicans (Brian Beathard, Michelle Foreman, and Lee Reeves) and 1 Democrat (LaRhonda Williams) running.

- Beathard brought in \$58,725 in contributions and a \$50K loan during the 2nd Q, spent \$145,449 and has \$65,418 on hand. Beathard has an outstanding loan balance of \$150 k in the 2nd Q filing.
- Foreman brought in \$15,046 in contributions and \$64,243 in loans during the 2nd Q, spent \$43,378 and has \$36,292 remaining on hand. Foreman has an outstanding loan balance of \$187,850 in the 2nd Q filing.
- Reeves brought in \$49,510 during the 2nd Quarter, spent \$15,529 and has \$83,687 remaining on hand. Reeves has an outstanding loan balance of \$50K in the 2nd Q filing.

Republican Primary winner will face Democrat, LaRhonda Williams:

- Williams brought in \$1,195 in contributions and a \$497 loan during the 2nd Q, spent \$497 and has \$1,570 on hand. Williams has an outstanding loan balance of \$497 in the 2nd Q filing.

House District 67 (part of Montgomery County)

Incumbent Representative Ronnie Glynn will not face a primary opponent but will face Republican candidate Jamie Dean Peltz in the General.

- Glynn brought in \$45,197 during the 2nd Q, spent \$18,689 and has \$46,805 on hand.
- Peltz brought in \$24,250 during the 2nd Quarter, spent \$14,752 and has \$9,498 on hand.

House District 68 (part of Montgomery County)

Open seat: Curtis Johnson not running

4 Republicans (Carol Duffin, Greg Gilman, Aron Maberry, and Joe Smith) running for the seat

- Duffin brought in \$1,910 during the 2nd Quarter, spent \$11,709 and has \$5,831 remaining on hand. Duffin has an outstanding loan balance of \$10,100 in the 2nd Q filing.
- Gilman did not bring in any contributions during the 2nd Quarter but received loans in the amount of \$15K. Gilman spent \$13,346 and has \$1,754 remaining on hand. Gilman has an outstanding loan balance of \$15,100 in the 2nd Q filing.
- Maberry brought in \$7,465 in contributions and a \$450 loan during the 2nd Q, spent \$18,520 and has \$2,737 on hand. Maberry has an outstanding loan balance of \$5,350 in the 2nd Q filing.
- Smith brought in \$40,655 in contributions and \$70K in loans during the 2nd Q, spent \$57,147 and has \$68,530 on hand. Smith has an outstanding loan balance of \$71,800 in the 2nd Q filing.

1 Democrat (Garfield Scott) is running

- Scott brought in \$2,499 in contributions and \$1,500 in loans during the 2nd Q, spent \$2,687 and has \$1,312 on hand. Scott has an outstanding loan balance of \$1,500 in the 2nd Q filing.

House District 69 (Hickman and parts of Lewis and Dickson County)

Incumbent Representative Jody Barrett v. Ronny George in the Republican primary. No D running.

- Barrett raised \$26,019, spent \$16,837 and has \$81,377 on hand. Barrett has an outstanding loan balance of \$486.
- George raised \$2,300 and with no spending, has a balance of \$2,300.

House District 73 (Part of Madison County)

Incumbent Representative Chris Todd v. Jimmy Harris in the Republican primary. No D running.

Chris Todd v. Jimmy Harris

- Brought in: \$148K v. \$81K
- Spent: \$103K v. \$92K
- On hand: \$210K v. \$60K

House District 77 (Dyer, Lake, and part of Obion County)

Incumbent Representative Rusty Grills versus James T. "Bubba" Cobb in the Republican primary. No D running.

Rusty Grills v. Bubba Cobb

- Brought in: \$81K v. \$12K
- Spent: \$41K v. \$9K
- On hand: \$137K v. \$3K

House District 78 (Cheatham and part of Dickson County)

Incumbent Representative Mary Littleton versus Justin Spurlock in the Republican primary. Winner will face Democrat Deborah Castle Doyle.

Mary Littleton v. Justin Spurlock

- Brought in: \$54K v. \$3K

- Spent: \$41K v. \$1K
- On hand: \$114K v. \$1K

House District 80 (Parts of Hardeman, Haywood and Madison Counties)

Incumbent Representative Johnny Shaw will face 2 opponents in the Democratic Primary: Jonathan Joy and Shelia Godwin. No R running.

- Johnny Shaw brought in \$18K, spent \$7K and has \$24K on hand.
- No report for Joy.
- Godwin has \$59 on hand.

House District 84 (Part of Shelby County)

Incumbent Representative Joe Towns faces Vernell Williams. No R running.

- Joe Towns brought in \$900, spent \$2K, and has \$72K on hand.
- No report from Williams.

House District 86 (Part of Shelby County)

Incumbent Representative Justin Pearson faces David Page. Independent Jeff Johnston in the general.

- Justin Pearson brought in \$15K, spent \$67K and has \$124K on hand.
- Page has \$0 across the board.

House District 93 (Part of Shelby County)

Incumbent Representative G.A. Hardaway faces Lashanta Rudd. No R running.

- A 2nd Q report has not been submitted from Hardaway. End of the 1st Q balance was \$91,452.
- \$0 reported for Rudd.

House District 96 (Part of Shelby County)

Open seat: Dwayne Thompson not running

5 Democrats are running and no Republicans (Eric Dunn, Telisa Franklin, Gabby Salinas, Orrden Williams, and David Winston)

- Eric Dunn and Telisa Franklin have not filed any reports.
- Salinas brought in \$31,991 in during the 2nd Q, spent \$19,035 and has \$21,425 on hand.
- Williams did not report any contributions or spending in the 2nd Q and has a balance of \$0.
- Winston brought in \$1,216 in contributions and \$600 in loans in the 2nd Q, spent \$5,370 and has a negative balance of (\$3,554) remaining. Winston has an outstanding loan balance of \$600.

House District 97 (Part of Shelby County)

Incumbent Representative John Gillespie faces Christina Oppenhuizen. The winner will face Democrat candidate Jesse Huseth in the General Election.

- Gillespie brought in \$39,250 during the 2nd Q, spent \$27,196 and has \$85,849 on hand.
- Oppenhuizen brought in \$1,697 during the 2nd Quarter, spent \$1,390 and has \$307 on hand.
- Huseth brought in \$42,837 in contributions during the 2nd Quarter, spent \$11,463 and has \$81,489 on hand. Huseth has an outstanding loan balance of \$3,600 in the 2nd Q filing.
